In case, if it is found subsequently that any of the promoted/selected candidate was not eligible for the

examination/selection under the existing rules/instructions on the subject or for any other reasons or in case any mistake is found with regard to declaration of result of any candidate for any reason whatsoever, his/her name will be deleted from the list of successful candidates, as the case may be. This result is also subject to any change in the merit list of successful candidates due to any unforeseen reasons in accordance with the existing rules and instructions on the subject.


6. The result of all successful candidates is subject to fulfilment of eligibility criteria to be decided by the concerned Divisional/Unit Head and vigilance status of the candidates. The official/candidate against whom vigilance or disciplinary case is pending/those undergoing punishment should not be promoted and such cases should be referred back to this office as per directions of Dte's letter No X-7/6/2022-SPN-II dated 17.05.2023, 22.09.2023 & 04.03.2024.

7. All the Divisional Heads/Appointing Authorities are requested to cause issuance of promotion/appointment orders immediately but not later than 18.10.2024. The appointment authorities are also requested to carry out all the required pre-appointment formalities as provided in relevant rules and instructions issued from time to time. Joining process should be completed on or before 23.10.2024. A consolidated report should be submitted to this office on 24.10.2024 without fail.

8. The Divisional/Unit heads are requested not to send separate letter of carrying out joining process/appointment letters to Circle Office. **In Case the candidate does not join the recruited post within 7 days it will be deemed to have been refused and next candidates will be considered. (Refer guideline issued by Directorate No 17-08/2018-SPN-I dated 15th June 2022 Circulated vide CO endorsement number STA 11-9/A/PM-MG Exam Rlg/539 Raipur Dated 17.06.2022).**

9. Divisional/Unit heads are requested to get the candidates joined at the earliest and declination, if any, received from the selected candidates be furnished to this office for further action. Request for revised allotment of any candidate will not be entertained.
