2. These officials are qualified candidates of Inspector Posts Examination, 2016-17, 2017-18 and 2018, held on 16th-17th November 2019, vide Directorate letter No. A 34013/01/2020 –DE Dated 13.11.2020.

3. The appointing authority reserves the right to take action in case there will be any Disciplinary/vigilance case pending or contemplated or if the punishment is current/pending against any of the above officials as per provisions of the Rules. If so, a report be furnished at once to this office without relieving the officials for promotional post.


4. Verification of caste certificate: The caste certificate of the officer belonging to SC/ST category who have been promoted to IP cadre may be verified and it may also be ensured that caste / tribe of the officials belonging to SC/ST category are still figuring in the notified central list of Schedule caste / tribe before actually giving them promotion. A certificate having undertaken such verification in respect of concerned officials may be intimated to this office at the earliest.

5. The above officials will be on a probation for two years as per the rules on the subject.

6. If the officials wish to give option for choosing date of fixation of pay under FR22(1)(a)(i) should do so within one month from the date of promotion.

7. The local arrangements made if any in the posts where the above officials are posted will automatically be terminated.
