The above transfer under Rule-38 are approved subject to the following condition:-

1. The concerned Dn./Unit should ascertain that no Vigilance / Disciplinary cases is pending in respect of these officials and verification of educational/ caste and character antecedents etc. have been done found genuine.
2. The seniority of the official on joining duty in new unit will be determined in accordance with the provisions of Rule 38 of Postal Manual Vol. IV as amended from time to time.
3. He/She will not claim any TA/TP.
4. He / She will have to forego all claims for confirmation in the old unit even if a permanent vacancy was available because of retrospective permanency of the post or for any other reason for which he /she entitled to confirmation in his / her old units.
5. He /she will not claim repatriation to his/ her parent unit.
6. He/she after transfer to new unit will be eligible for confirmation in the new unit only according to his/ her position in the gradation list of the new unit.
7. The relieving unit is requested to see that no such official ordered to be transferred on this memo is actually relieving before the posting order in respect of the concerned official is received by him.
